**Note:** Generally, you may not take more than 52 weeks of leave in a rolling 52 week period under any and all policies combined. Any approved time under this leave may be deducted from the 52 weeks that are available to you. For the dates listed as job-protected, you will generally be able to return to your position or an equivalent one.

- **Return to work date:** 10/15/2023

## Pay

**PTO:** To receive pay during unpaid days, you may use available PTO time. Please coordinate with your manager/HR representative.

**Note:** Paid leave benefits, including disability payments, are calculated as of the last day worked before a leave begins. These benefits will not be affected by any events that affect pay during a leave. If a Workday-based associate is on leave when a pay increase occurs, the pay rate change will appear in Workday, but it will not affect the amount of paid leave benefits during the leave.
